The method to be used to determine the order of priority in which each of the persons interested in purchasing any of the specified residential properties may select the residential property that the person wishes to purchase :

On 3 September 2015 (the “first date of sale”):

1. Balloting will be used to determine the order of priority. Only individuals are permitted to participate in the balloting procedures. Persons interested in purchasing any of the specified residential properties (“**the registrant**”) must follow the procedures below.
2. A registrant must submit the following:-
 - (a) only one Registration of Intent duly completed and signed by the registrant;
 - (b) the Registration of Intent shall be accompanied with cashier order(s). The number of cashier order(s) shall be equal to the number of residential property(ies) which the registrant intends to purchase as indicated in the Registration of Intent, but such number of residential property(ies) in any event shall not exceed two (2). Each cashier order shall be in the sum of HK\$100,000 and made payable to “WOO KWAN LEE & LO”; and
 - (c) a copy of the registrant’s H.K.I.D. Card(s)/Passport(s)to the ICC Venue from the date on which relevant price list(s) of the specified residential properties are made available to 1 September 2015 (both days inclusive) during office hours (i.e. from 2:00 p.m. to 9:00 p.m. on Monday to Friday and from 12:00 noon to 9:00 p.m. on Saturday, Sunday and Public Holiday). The closing time for submission of Registration of Intent will be 9:00 p.m. on 1 September 2015.

If Typhoon Signal No. 8 or above is hoisted or Black Rainstorm Warning is issued at any time between the hours of 10:00 a.m. and 9:00 p.m. on any date on which Registration of Intent may be submitted, then, for the safety of the registrants and the maintenance of order at the ICC Venue, the Vendor reserves its absolute right to change the date and/or time (including the closing date and/or time) for submission of Registration of Intent to such other date and/or time as the Vendor may consider appropriate. Details of the arrangement will be posted by the Vendor on the website (www.centurylinkii.com.hk) designated by the Vendor for the Phase.
3. Each registrant shall only be registered under one valid Registration of Intent. Duplicated registration of registrant will not be accepted. Late submission or submission outside the office hours will not be accepted. The Registration of Intent is personal to the Registrant and shall not be transferable. The order of submission of the Registration of Intent will not have any impact on the order of priority for selecting the specified residential properties.
4. The cashier order(s) will be used as part payment of the preliminary deposit for the purchase of the specified residential property(ies).
5. All valid Registration of Intent submitted before the aforesaid closing time for submission will be included automatically in the first round balloting. In case of dispute, the Vendor reserves its right to determine whether a Registration of Intent is valid and should be included in the first round balloting.
6. Balloting will take place in batches:
 - (a) *First round balloting (for dividing all registrants into group(s))*

- (i) The first round balloting will take place at 1:00 p.m. on 2 September 2015 at the ICC Venue for the purposes of dividing the registrants into group(s). The Vendor reserves the right at any time, for the purposes of maintaining order at the ICC Venue and/or facilitating smooth sale of the specified residential properties, to adjust the time and date of the first round balloting. Any changes to the time and date of the first round balloting will be posted at the ICC Venue and at the lobby on 3/F, International Commerce Centre, No. 1 Austin Road West, Kowloon, Hong Kong. Registrants will not be notified separately of such changes.
 - (ii) After the first round balloting, the registrants will be divided into group(s) and the registrants in each group will be eligible to participate in the second round balloting as detailed in paragraph 6(b) below.

- (b) Second round balloting (for determining the order of priority of registrants in selecting and purchasing specified residential properties)
- (i) The second round balloting of the group(s) of registrants will take place on the first date of sale in batches at the ICC Venue at such time(s) as posted by the Vendor pursuant to paragraph 6(a)(iii) above. The Vendor reserves the right at any time, for the purposes of maintaining order at the ICC Venue and/or facilitating smooth sale of the specified residential properties, to adjust the time and date of the second round balloting.  - (ii) For the purpose of verification of identity, registrants must bring along his/her original H.K.I.D. Card(s)/Passport(s) and the original receipt of the Registration of Intent and personally attend the ICC Venue according to “check-in timeslot for each group” posted by the Vendor. The Vendor may, for the purpose of logistics, efficiency, convenience, safety and/or other reasons to facilitate the second round balloting, make use of the lobby on 3/F and/or 10/F and/or 27/F of International Commerce Centre, No. 1 Austin Road West, Kowloon, Hong Kong (collectively the “**Additional ICC Venues**”) to accommodate some of the registrants by making announcement at the ICC Venue and the Additional ICC Venues. In case of any dispute, the Vendor reserves its absolute right to allocate any specified residential properties to any person interested in purchasing by any method (including balloting).
10. The Vendor reserves the right to close the ICC Venue and the Additional ICC Venues (if applicable) at any time if all the specified residential properties have been sold out.

If Typhoon Signal No. 8 or above is hoisted or Black Rainstorm Warning is issued at any time between the hours of 7:30 a.m. and 9:00 p.m. on the date on which the first round balloting will take place pursuant to paragraph 6(a) above and/or the first date of sale, then, for the safety of the registrants and the maintenance of order at the ICC Venue and/or the Additional ICC Venues (if applicable), the Vendor reserves its absolute right to postpone the date(s) and/or time for the first round balloting and/or second round balloting and/or the first date of sale (as the case may be) to such other date(s) and/or time as the Vendor may consider appropriate and/or to close the ICC Venue and/or the Additional ICC Venues (if applicable). On 4 September 2015 and thereafter:

12. Subject to the completion of the balloting and the selecting and purchasing of the specified residential properties by eligible persons in accordance with the above procedures, the remaining specified residential properties (if any) will be sold on a first come first served basis to any person (including individuals, corporations or otherwise) interested in purchasing the specified residential properties. In case of any dispute, the Vendor reserves its absolute right to allocate any specified residential properties to any person interested in purchasing by any method (including balloting).

- (a) 遞交一份已填妥及由登記人簽署的購樓意向登記；
