Net purchase price means the amount of the purchase price of the residential property after deducting the Stamp Duty Cash Rebate (if any) as set out in paragraph (4)(SC1)(iii)1(a), the HK\$5,000 Cash Rebate (if any) as set out in paragraph (4)(SC1)(iii)1(b) and the Early Settlement Cash Rebate (if any) as set out in paragraph (4)(SC1)(iii)2.
